Where to Download Toolkit Resources

Background

The Emergency Broadband Benefit Program is a Federal Communications Commission (FCC) program that provides a temporary discount on monthly broadband bills for qualifying low-income households.

If a household is eligible, they can receive:

- Up to a \$50/month discount on your broadband service and associated equipment rentals
- Up to a \$75/month discount if your household is on qualifying Tribal lands
- A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (with a copayment of more than \$10 but less than \$50)

Only one monthly service discount and one device discount is allowed per household.

The program will begin in spring 2021 and end when the fund runs out of money, or six months after the Department of Health and Human Services declares an end to the COVID-19 health emergency, whichever is sooner.

Purpose

Given that the Emergency Broadband Benefit Program is temporary, it is important that consumers are made aware of the program and given the opportunity to participate as soon as possible. To



encourage and assist consumer outreach, USAC has created resources in this toolkit that organizations can use instead of creating outreach from scratch.

Consumer advocacy groups, social service agencies, and other organizations that support broadband customers are welcome to print and distribute any or all of the toolkit's resources in their communities. Additionally, all are welcome to integrate the web banners and tiles into their websites.

We encourage any necessary translation of these resources in order to share them beyond Englishspeaking communities.

Finally, a primary goal of consumer outreach should be to direct potential participants to the EBB Program's consumer information and application website: <u>GetEmergencyBroadband.org</u>. If independently create consumer outreach materials, we ask that you still direct consumers there.

The @FCC has a new #COVIDRelief program in 2021: Low-income households can apply for the Emergency Broadband Benefit, which includes monthly broadband discounts, an Enhanced Tribal Benefit, and a device discount.

You might qualify for a temporary @FCC program that offers #COVIDRelief discounts of up to \$50 per month on your monthly broadband bill. Device discounts and an Enhanced Tribal Benefit are also available.

If you live on Tribal lands, you may qualify for Emergency Broadband Benefit's Enhanced Tribal Benefit: a discount of up to \$75 per month on your monthly broadband bill.
